4. Legal Basis and Purpose of Processing Personal Data	<p>Recser Oy Producer Register is a register of producers of batteries and accumulators in Finland, that has signed a Producer Responsibility Transfer Agreement with Recser Oy Ltd.</p> <p>Recser Oy manages the obligations under Finnish legislation, implementing the Directive 2006/66/EC with regards to producers of portable batteries and accumulators, on behalf of producers who have contracted it. Each producer is registered in accordance with Finnish legislative requirements.</p> <p>The information contained in the register is used only to the extent necessary for the purposes of allocating producer responsibility and enabling enforcement and official controls.</p>

Regular sources of Data and Regular disclosure and transfer of Data	<p>The Register keeper uses external subcontractors to handle the tasks described in this policy, and in such cases, the service providers act on behalf of the Register keeper. Subcontractors, i.e. recipients of personal data, include data system suppliers. The Register keeper is responsible for the activities of its subcontractors as for own activities and ensures, by means of data processing agreements with subcontractors, that these parties are committed to protecting the personal data in the manner stated in this document.</p> <p>Following data is transferred monthly to authorities to enable enforcement of producer responsibility legislation: Producer / Business ID, VAT number / Address / Postal code and -city / Country / Producer responsibility transfer agreement start date.</p> <p>The following data is disclosed on register keepers website, paristokierratys.fi: Producer / Business ID, VAT number</p>

8. Rekisterinsuojauksen periaatteet	<p>Only persons with access rights have the right to process personal data contained in this register for the purposes of carrying out their work. Each user has their own username and password for the system. Data is collected in databases that are protected by firewalls, passwords, and other technical measures</p> <p>Personal data is stored for as long as it is necessary for fulfilling the purpose of the register. The Register keeper will regularly assess the need for the storage of personal data, and will also take reasonable measures to ensure that incompatible, obsolete or inaccurate personal data is not saved in the register.</p>
9. Rights of the Data Subjects	<p>At any time you can unsubscribe from our mailing list by The data subject has the right to inspect the data on him or her that is stored in the register, as well as to demand that any incorrect data be corrected and that any data on him or her be deleted from the register.
